The Priority Center's unique programs address the specific needs of the families we serve to ensure that children live in violence-free homes. Unfortunately, the past few years have been some of the most challenging for families in Orange County. Currently, 92% of our clients come from low-income families. Economic pressures continue to strain our clients' abilities to meet even basic needs. The Priority Center continues to be a beacon of hope for Orange County's most vulnerable families, who often feel voiceless.

Our eight life-changing programs are provided at no cost and help individuals and families navigate social isolation, poverty, depression, lack of resources, suicidal ideation and loss of hope. This past year, The Priority Center's compassionate staff provided support to more than 8,400 clients, but there are still many more individuals who need our help.

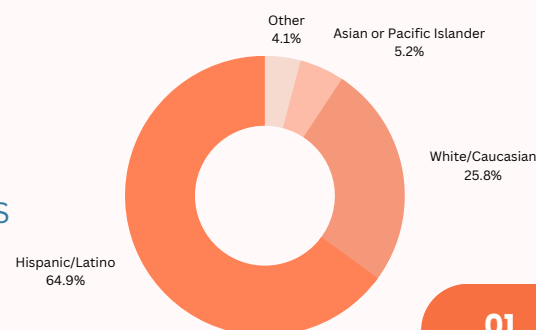
